Firstly, we are a Society of "Commissioned Sales Representatives". All new Members must take out a full membership into A.M.W.A.A. at a cost of \$500.00 plus G.S.T., new members must be approved by our board. Once membership based on proof of commissioned Sales Rep status is provided an Annual membership fee of \$100.00 is collected semi-annually through market applications. If one chooses not to attend a show the \$50.00 fee must be submitted to maintain your membership, failure to do so cancel's ones membership. Our show is also under the CAWS umbrella. www.caws.ca Dues of \$300.00 per year are collected semi-annually on your market application.

We hold two markets a year, one in March and one in September. Our Market fee is \$225.00 plus G.S.T.

Our show is held at the Edmonton Northlands Agricom complex.
